I agree to assume, and do assume, such risks of injury without reservations, thereby releasing and forever discharging CR&PC, its officers, directors, agents, shareholders and employees, holding all and each of them harmless from any and all claims, actions, suits, procedures, cost, expenses, damages and other liabilities including, but not limited to attorneys fees, arising out of, connected with, or otherwise resulting from any injury not the direct result of the actions of an employee or agent of CR&PC. I specifically agree that this Release is unconscionable, is fully enforceable and that my execution hereof is completely voluntary.

Furthermore, I assume any and all risk to my person and/or property and agree to fully indemnify CR&PC, its officers, directors, agents, servants or employees against any and all liability by reason of any claim or demand by myself or any of my guests, or by any other person as a result of my actions or the actions of my guests on the premises.
